  The quotation received after the scheduled time will not be considered at all.
- 2. The envelope consist of the rates quoted along with any other documents should be super scribed as "Providing Job Work Services For Removing Sludge From Septic Tank Near G Type Quarters & Cleaning of Rain Water Harvesting Lines at ICAR-IASRI Campus, Pusa, New Delhi-110012". The quotation without superscription is liable to be rejected.
- 3. The right to accept the rates and bidding the work based on the quality rests with the DIRECTOR, ICAR-IASRI, NEW DELHI and it cannot be challenged. DIRECTOR,

- ICAR-IASRI, NEW DELHI reserves the right to accept or reject any one or all the quotations without any reason.
- 4. No advance and any part payment will be made for this work.
- 5. The rates are to be quoted to have a minimum validity for a period upto **90 days** and the rates are to be quoted with cost and supply of all materials at site, including all taxes, GST, transportation of materials and labour charges etc., for each item of work
- 6. Appropriate percentage of income tax on total billed amount will be deducted as TDS and the same will be remitted to the IT Department concerned.
- 7. A demand draft for an amount of Rs. 7600 /- (Rupees Seven thousand Six hundred only) may be drawn in favour of "ICAR-IASRI", payable at Canara Bank, IASRI Branch, (IFSC-CNRB0019142), New Delhi-12, towards the earnest money deposit should be enclosed along with the quotation.
- 8. Performance guarantee deposit 3% value of contract (Interest free) has to be deposited on receipt of this office letter before commencement of work in the form of Account Payee Demand Draft, Fixed Deposit Receipt from a commercial bank or online payment in an acceptable form safeguarding the purchaser's interest in all respects.
- 9. In case of delay in completion of the contract, liquidated damages should be levied at 0.5% per week of the contract value, subject to a maximum of 10% of the contract value.
- 10. During execution of work any loss/Hazard due to any reason for the men and materials will be borne by the contractor. The Institute will not be responsible for any loss or damage /Hazard.
- 11. The minimum wages shall have to be paid to the labour engaged by the contactor.
- 12. The Contractor/ Agency shall abide by all laws of the land including Labour Laws, Company Act, tax deduction liabilities, Welfare measure of its employees and all other obligations that enjoin in such cases and are not essentially enumerated and defined herein. Though any such onus shall be the exclusive responsibility of the Contractor/ Agency, and it shall not involve the institute in any way whatsoever.
- 13. While executing the work, the executing agency is fully responsible for any damage to Institute materials and the same may be replaced (including materials & labour charges for the replacement) by the Contractor at his own cost.

14. The work should be completed on or before 30 days from the date of work order to the

satisfaction of the authority concerned.

15. The rates are to be quoted, both in figures and words in the enclosed schedule otherwise it

will be rejected.

16. The rate should be quoted including GST and other applicable taxes. No separate deduction

/ payment will be made by this Institute and it is the responsibility of the contractor to make

necessary arrangements to remit the taxes to the concern authorities.

any stage including submission of false information strict/legal action as per rules/law shall

be initiated against the tenderer regarding forfeiture of performance security deposits.

20. In case of dispute or difference arises between successful bidder and department relating

to any matter connected with this contract, the same may be settled through amicable

negotiations between both, failing which the dispute shall be submitted to arbitration in

accordance with the provisions of the Arbitration and Conciliation Act and the Arbitrator's

decision shall be final and binding. The venue for conciliation and/or arbitration

proceedings shall be New Delhi, India.
